Competition Guidelines

1. Background

In accordance with China’s innovation-driven development strategy, Macao is embracing a significant opportunity to integrate into the overall national development. Supported by the Belt and Road Initiative, the development of the Guangdong-Hong Kong-Macao Greater Bay Area, and the innovative institutional environment of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin, Macao will remain committed to its strategic positioning as “One Centre, One Platform, One Base” and “One Highland”. By leveraging its unique advantages of reinforcing connectivity and the fusion of Chinese and Western cultures, Macao aims to deepen all-round, mutually beneficial cooperation with Portuguese-Speaking Countries and other international partners.

Building upon this foundation, Macao will further consolidate and enhance the strategic functions of the “Platform between China and Portuguese-Speaking Countries” and its global connectivity, fostering profound exchange and cooperation between China and the international community in the field of technological innovation. On one hand, Macao will be developed into an efficient and pragmatic hub for international scientific and technological cooperation, facilitating the convergence of innovative resources and the transformation of scientific achievements. This initiative aims to support Macao’s appropriate economic diversification and sustainable development while injecting innovative momentum into the construction of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin.

On the other hand, Macao will serve as a bridge for outstanding overseas technology enterprises to enter the Chinese Mainland market, promoting effective alignment with the Chinese Mainland’s vast market scale, advanced technical capabilities, and abundant capital resources. By establishing a mutually beneficial and synergistic cooperation mechanism, it aims to promote complementary strengths and collective advancement between China and foreign partners in tech innovation and industrial development, injecting sustained impetus into the high-quality development of the regional economy.

2. About the Competition

The Innovation and Entrepreneurship Competition (Macao) for Technology Enterprises from Brazil and Portugal has been held every year since 2021. In an effort to further expand the Competition's reach to other international markets this year, the event will be officially renamed the "Macao Technology & Innovation Competition for the Lusophone and Hispanic Countries" (hereinafter referred to as "Competition") and will adopt the approach of "recommended by localities, reviewed in Macao, settled in the Greater Bay Area" to provide ample development opportunities for international innovative startups. The startups taking part in the Competition are recommended by international organizations such as incubators and higher education institutions, and will be selected by the judging committee consisting of professional investors, academics, heads of financial institutions, and representatives of incubators, etc. In addition to prizes and certificates, the winning startups will also have the opportunities to be referred to renowned venture capitalists, financial institutions, incubators and other tech enterprises in China, enabling them to get a head-start in finding partners and capital resources in the Greater Bay Area. This year, the Competition will adopt a "One Application, Two Competitions" format. Upon registering for this event, all participating projects will automatically qualify for the "China-Portugal-Spain International Science and Technology Innovation Competition" (To be confirmed).

Furthermore, the award winners will be eligible to take part in the Delegation of Technology Enterprises from Portuguese-Speaking Countries to the Guangdong-Hong Kong-Macao Greater Bay Area, showcase their projects in major exhibitions in Macao and have the opportunities to network with different entrepreneurial ecosystem stakeholders in the Greater Bay Area. Participants can also utilize Macao as the Commercial and Trade Co-operation Service Platform between China and Portuguese-speaking countries and the Centre for Science and Technology Exchange and Cooperation between China and Portuguese-Speaking Countries to obtain opportunities for exchanges, demonstration and matchmaking during the exhibition and competition.

3. Competition Schedule and Entry Requirements

3.1 Call for entries: **From now until May 3rd, 2026**. Interested parties must submit their application materials, **application form, company logo, any road show materials (such as PPT or Brochure)** and a **5-minute pre-recorded project roadshow video**.

- Video and Pitching Language: English

- Video Resolution: 720p/1080p

- Video Format: MOV/MP4

3.2 Final:

3.2.1 Date and Time: June 16th, 2026 (Tuesday), 9:00 a.m. (GMT+8);

3.2.2 Venue: Macao Science Center;

3.2.3 Contest: The judges will evaluate the projects based on the **5-minute pre-recorded roadshow video** of each participating project and the **3-minute online Q&A session** on the day of the competition.

3.3 Result Announcement:

The results will be announced on the day of the final contest or through the official channels and media (websites, Facebook pages, WeChat Official accounts, etc.) of the Organizer and Implementers.

4. Awards, Prizes, and Incentives

4.1 Champion, 1st Runner-up, 2nd Runner-up, and other major awards:

- **The prize for the Champion, 1st Runner-up, and 2nd Runner-up will be disbursed in two installments (upon the conclusion of the competition and upon local business registration):**
- **First Installment (50%):** Award winners may apply for disbursement following the conclusion of the competition.
- **Second Installment (50%):** Award winners apply for the award upon formal registration and incorporation in Macao or Hengqin on or before December 31st, 2027.
- **Failure to complete local business registration within the prescribed period will be deemed a voluntary waiver of the second installment of the prize.**

4.2 Other incentives and opportunities

The award winners of the Competition will have the opportunity to connect with venture capitalists, financial institutions, incubators and other tech enterprises at the recommendation of the Organizer. In addition, if the awarded startups are interested in setting up their operations in the Greater Bay Area and intend to conduct on-site visits for finding partners and financing, qualified teams may be subsidized by the Macao SAR Government for the visits. Details will be announced later.

5.1 Participating startups must fall into one of the following technology areas:

5.1.1 Integrated Circuit / Electronic Component and Device;

5.1.2 Biomedicine / Medical Devices;

5.1.3 Biotechnology;

5.1.4 Big Data/ Artificial Intelligence (Including Autopilot Technology/ Intelligent Manufacturing Technology/ Internet of Things Technology Services/ Blockchain Technology/ Interactive Technology/ Cloud Computing/ Edge Computing/ Wearable Devices/ Intelligent Drones, etc.);

5.1.5 New Materials /New Energy.

5.2 Project teams shall have the intention to seek business opportunities and establish companies in the Greater Bay Area.

8.4 If the participating startups own the intellectual property rights of their contesting projects, they must ensure that no intellectual property rights of any individual or entity are infringed. The responsibility for protecting the intellectual property rights or any other rights of the contesting projects rests solely with the participating startups, and the Organizer shall not assume any responsibility for protecting the intellectual property rights or any other rights of the participating startups;

8.5 Projects that have won the awards in previous Competitions are not eligible to participate in the Competition;

8.6 The awarded startups of the Competition are required to participate in the promotional activities held by the Organizer;

8.7 For the purpose of arranging business matching and other follow-up activities in the future, the Organizer reserves the right to grant the project information submitted by the participants to the relevant third-party organizations for referral purposes.

9. Remarks

9.1 All the personal information submitted by the participating startups will be handled by the Organizer in strict protection accordance with the provisions of Law No. 8/2005, the Personal Data Protection Act. The information provided will be kept strictly confidential and will only be used for the purpose of the Competition and related activities;

9.2 The Competition features a “One Application, Two Competitions” model this year. Consequently, the project information submitted by participants will be shared with the organizers of the “China-Portugal-Spain International Science and Technology Innovation Competition” for registration purposes.

9.3 The finalists of the Competition must cooperate with the Organizer in required promotional activities, and the Organizer reserves the right to use the photos and videos taken during the activities for promotional purposes;

9.4 The Organizer reserves the right to revise the Competition Guidelines without prior notice, should any aspect be found inadequate;

9.5 The Organizer reserves the right of interpretation and final decision regarding the Competition;

9.6 The Chinese version of the Competition Guidelines shall prevail in case of dispute.
